A WORD FROM YOUR VICE PRESIDENT

Continued work on the reduction of past due assessments is your Vice President's goal. Since January 2012 till present, we have been able to remove \$6395.00 of delinquent accounts through foreclosures, collections, tax sales, resales, and legal action. I have signed the final paperwork for several accounts with court dates in June 2012. Closing of these accounts will significantly reduce the amount of outstanding dollars. After the judgements in June, I will have our attorney start paperwork on the next series of accounts requiring court action.

The monthly minutes, quarterly newsletters, all of our documents and resolutions, plus much more of the association data have been loaded onto external hard drive and back up disc for their protection.

Being happy to donate a nice mix of plants for the lake again this year, Gary Bowers, Rick Hardy, and Cindy Fitz were able to help me with planting on Clean-Up Day, May 5, 2012. The plants I have donated will help to make a healthier environment for fish and wildlife, in other words, cleaning the water and providing cover for hatchling fish as they grow. Keeping these plants thriving is so very important, as we want our grandchildren to enjoy the lake as much as we have.

Plants donated by Rick Roscoe were planted at the lake while Rick and Brenda Inclima pursued restoring the sand erosion barrier for the beach. Special thanks to Roger Brown and Shawna Mouser for tackling the challenge of removing wood and debris collecting under the dock and installing the new collar for the lake. The collar is designed to raise the water level that accesses the boat ramp and gives our lake inhabitants a larger supply of fresh water and a little more wiggle room. Roger should also be commended for fabricating two new ball field benches for our little "slugger's" games as well as orchestrating the replacement of our new Sleepy Hollow Community sign. You may have noticed that a portable toilet has been installed at the ball field or pavilion, hopefully enticing more people to reserve these facilities for their family gatherings and special events. To date, four confirmed reservations are on the calendar, with many more warm weather weekends available to claim your own. Cost for electricity is \$5.00 per day. Contact me if interested.

RESUMES "

A request for resumes was published in the February 2012 Newsletter. Candidates wishing to stand for election were requested to send resumes via mail to SHLOA Election Committee or submit their resumes to a member of the election committee by the Date of Record. All resumes had to be received by April 15, 2012 to be published in this newsletter

ENTITLEMENT TO VOTE

Each lot of the association shall entitle the Owner(s) to one (1) vote per lot, providing all assessments are paid by the date of the Annual Meeting.

BALLOT CARD(S)

All votes for the Board of Directors shall be made on official ballot cards mailed to you by the Election Committee and will contain the rosters of nominees who submitted resumes by April 15, 2012 and a space for write-in votes for each vacancy. Such ballots will be mailed to each Owner of Record by the V.P. of Communications, on or before May 17, 2012. Members owning more than one lot will receive a ballot card for each lot they own.

RETURN OF BALLOTS

All official Ballot Cards must be returned to the Election Committee via United States Mail and postmarked no later than June 11, 2012 (to ensure receipt before the Annual Meeting). The Owners' Information will appear in the upper left corner of the front of each Ballot Card specifying the Section and Lot number and Lot Owner's name for which that lot owner can cast an eligible vote. DO NOT REMOVE THE RETURN LABEL. THE NAME OF THE OWNER(S) MUST BE ON THE RETURNED BALLOT TO VERIFY THE OWNER(S) ARE MEMBER(S) IN GOOD STANDING. AT LEAST ONE (1) OWNER OF RECORD MUST SIGN THE BALLOT CARD.
