I released two liens on property after final payment of late assessments was made. We received payments and closed another three delinquent accounts. Additionally, the Association was awarded another judgment for \$1,500.00 from the Circuit Court of Berkeley County.

I recently signed affidavits for two additional cases with the Circuit Court of Berkeley County, and negotiated and settled another significant case out of court. This information might seem redundant or insignificant; however I want you (property owners) to know that the delinquent accounts are still being pursued. Assuring everyone pays their assessment provides fairness to every lot owner and helps keep our assessment fees among the lowest in the area.

Finally, I would like to make you aware that in October hunting season will be starting and hikers, dog walkers etc. walking within the confines of Sleepy Creek should be careful and wear a bright orange outer garment. You should also be aware that the general public has access to Sleepy Creek via the top end of Audubon Road, end of Maverick Lane and Devils Nose Jeep Trail.

A MESSAGE FROM YOUR VICE PRESIDENT OF ROADS

It has been a busy summer season for road maintenance. We have completed all grading and crowning of dirt roads and added shale where necessary to improve surface and stability. We have also completed installation and/or relocation of several culverts under our unpaved roads to improve drainage and reduce erosion. In addition, all drainage ditches have been cleaned and cut to facilitate runoff and protect our roads. Finally, we are close to completing a rebuild of the fence over the lake dam on Audubon Road for the safety of our residents and guests.

A MESSAGE FROM YOUR TREASURER

Below is a copy of the SHLOA year-to-date budget as of August 2013. The overages in **Common Facilities/Maintenance** are due to the Board-approved safety improvement for the guard rail on Audubon Road over the dam. The overage in **Roads/Upgrades/Maintenance** is due to repairs/maintenance to roads and ditches caused by storm damage. Currently, we have \$3,848.72 in the available 2013 Reserve Fund that can be used to offset any overages. Additional funds as required will be transferred at the end of the year from the Capital Improvement and Emergency Funds, subject to approval by the Board of Directors.



Division of Natural Resources Warns: Don't Feed the Bears!

The Division of Natural Resources cautions all West Virginia residents that the feeding of black bears is a violation of state law, as well as a misguided disservice to our state animal, according to Christopher Ryan, Black Bear Project Leader for the Division of Natural Resources Wildlife Resources Section.

"It is understandable that some people will illegally set out food to get a glimpse of this magnificent animal," Ryan said. "However, too often these actions regrettably result in the death of the bear. Bears that wander near residential areas in search of food are less likely to stay if they do not find anything to eat."

Bear populations have increased and expanded across the state in the last 10 years. "We have been receiving numerous calls concerning bear sightings from areas that have not had bears in



the recent past. Bears have been reported in all 55 counties and we have received many reports of sows with cubs in the northern and western portion of the state."

Bears often become habituated to handouts and lose their fear of humans. When bears lose this fear they resort to raiding garbage, outdoor freezers, and other food sources associated with people. Unfortunately, if these activities are repeated, Division of Natural Resources personnel are forced to humanely destroy the offender for safety reasons.

"Unintentional feeding of black bears is a major concern to the Division of Natural Resources," Ryan said. "People need to secure garbage in bear-proof facilities and place trash out for collection on the morning of pick-up. Residents should remove all outside pet food at night, and bird feeders should be taken down, cleaned, and stored until late fall to further discourage feeding around human habitation."

Feeding of any wildlife should be avoided for numerous reasons including but not limited to disease transmission, increased predation, habitat destruction around the feeding site, ethical concerns, and the animal's overall health. Following these practical and common sense recommendations will reduce bear-human conflicts and assure that more of the state's animals will remain wild.

For more information on how to discourage nuisance bears or anyone experiencing bear problems should contact the local DNR District Office.
