A Word About our Winter Roads

All of us on the SHLOA Board know what a difficult winter we have had. Whether we live fultime in this community or elsewhere in the area, we have experienced extreme snow, sleet, ice, and freezing temperatures. It has not been easy keeping all of the roads cleared and open all the time no matter where we live. However, with so many miles of dirt roads (12 miles) in Sleepy Hollow, our snowplowing contractor and our Vice President of Roads have worked very hard to keep our roads open. Be aware that our snow plow contractor, Emerick, is a contractor for other communities too. We cannot afford to have a contractor exclusively at our beck and call plowing our development 24/7.

Think back a lot of years when this community was first built. Many families first bought their properties back in the early 1970's or thereabouts. Back then, all the roads were dirt/gravel and were cut by the developers without much forethought as to proper engineering, drainage, or future maintenance.

Sleepy Hollow was originally developed as a Recreational Community where people only came for weekends and vacations. Our roads were unfortunately cut with many hills that are very steep. We did not have a "Board" at that time so the roads were not even plowed in the winter. People who owned property just stayed away when it snowed, owned a four wheel drive vehicle, or used chains and good snow tires to get in and out through the unplowed roads.

The Board budgeted \$11,500 for plowing this past year and we have exceeded this amount due to this winter's severity, having spent at least \$13,935 before the last big storm.

We are all happy that people have chosen to live here fulltime; it's a great community. We understand that our winter residents and part timers want the roads plowed pristine and in a timely manner, and the Board tries its very best to meet those demands while staying within our available financial resources.

However, the fact remains that most of the roads are still dirt/gravel and are quite hilly and difficult to navigate in the winter. Dirt roads cannot be treated like paved roads. Salt cannot be put on dirt roads or they will just turn into a muddy mess; they can only be treated with cinder or sand. They cannot be plowed to the bare ground because all the stone will be plowed away and then we will be left with water/ice-filled pot holes and ruts that will impede travel in the winter and necessitate extensive grading and stoning in the spring.

Last year we budgeted \$14,000 for dirt road maintenance and spent almost the whole amount fixing, grading and stoning our roads after the winter. The Board cannot fix winter weather; we can only request that you understand the problems involved with living on a dirt/gravel road. We do our very best to plow you out. In fact, our roads are often cleared earlier than

most but people cannot get beyond our development because Mountain Lake Road is not plowed.

We hope this message gives you some understanding of the unique problems that our snowplowing contractor and our Vice President of Roads face whenever it snows, sleets, or we have an ice storm. We all work really hard and our contractor and our VP of Roads do their very best to keep our roads open. They spend as much time as possible to accomplish this in the face of significant challenges.

Full time residents must remain prepared to deal with delays caused by winter weather. Stock up on food, fuel, medications, and other essentials to assure you will not be left shorthanded in the event of severe storm. Make sure your vehicle is equipped to handle the winter weather and be sure to make contingency plans whenever Mother Nature challenges our regular routine. Remember, "You can't fool Mother Nature;" you can only anticipate her fury and prepare your family to "ride out the storm" and its inevitable aftermath.

Sleepy Hollow Snow Plowing Policy

SHLOA follows a long-established policy regarding the plowing of roads during winter weather. The policy states clearly that roads are plowed whenever the depth reaches 3 inches anywhere in the development. We have unpaid volunteers checking on snow depth throughout the community especially in the problem areas. If the depth is not 3 inches, our longstanding policy is that we do not plow due to our limited plowing budget.

The "Call for Resumes" published in this edition is the official request for candidates to submit a brief description detailing their willingness to serve on the Board and any other information they would like to share with the community. Please consider serving your neighbors and the greater Sleepy Hollow community by submitting a resume. Watch your mailbox for the "Call for Resumes" flyer in the second half of March 2014. The name of every candidate who submits a resume will be printed on the official ballot mailed to all eligible lot owners in May 2014.

The SHLOA Bylaws require that the official ballot also provide a space for write-in candidates. You might be asking yourself, "What is a write-in candidate?" A write-in candidate is simply a name you write in (usually your own name) on the ballot, basically voting for yourself (or another known write-in candidate) for a position on the Board. Write-in candidates are rarely elected, even in state and local political elections, due to the fact that most voters will have no way of knowing you are interested in being elected. Therefore, the Board strongly encourages you to submit a resume in 2014 so we can publish same in the 2nd Quarter newsletter and print your name on the official ballot.

If you think that running for election to the SHLOA Board is not important, think again! Our assessments are the lowest in the area by a long shot. Our neighbors in surrounding communities pay several times more in yearly assessments due to the lack of volunteers and the necessity to hire "professional managers" to run the affairs of the community. If you have any questions about how to run for a Board position or what it entails, please contact any member of the Board. We welcome your inquires and will do everything we can to make your service to our community a rewarding and satisfying experience.

COMMUNICATIONS UPDATE



SHLOA's web site, <u>www.shloa.com</u>, is our preferred method of keeping you informed. Many newspapers and magazines have converted to web-based publications as a cost saving measure. Sleepy Hollow's newsletter printing and mailing costs continue to climb. Therefore, we are moving incrementally towards increased web-based communications in an effort to keep you informed of current events while simultaneously saving your hard-earned assessment dollars. The website is updated regularly and can provide timely and relevant news that cannot be provided in a quarterly publication. Please visit our website regularly.

In our continuing efforts to save assessment dollars while maintaining services, we sent out a survey with the 2014 assessment notices to gauge owners' interest in receiving future editions of the SHLOA newsletter via email. Of the 258 surveys returned as of February 10, 2014, 83 owners expressed an interest in receiving future newsletters via email, 41 responded with a no, and 134 residents did not indicate a preference. Our Director of Communications is building a database to facilitate email transmission of the newsletter and we hope to begin electronic distribution in time for the May 2014 edition.

Any homeowner who has not already indicated their wishes via the survey is welcome to sign up for electronic newsletter distribution by sending an email to SHLOA at <u>Sleepyhollowhoawv@yahoo.com</u>. Please put "newsletter" in the subject line, and include your name, mailing address, lot number & section, and email address. We will gladly accommodate your request and send future newsletters directly to your inbox. What's easier or more convenient than that?

The monetary and environmental cost of printing and emailing SHLOA newsletters continues to climb. Each printed and mailed edition costs SHLOA approximately \$500.00. We are currently mailing and printing 2 editions per year at significant cost (estimated \$1,000.00 + per year). Ultimately, our intent is to reduce the annual cost of producing the newsletter to zero (\$0.00) by moving fully to an electronic format (i.e., email and web posting) in the future. The savings will be put towards insurance, taxes, licenses, permits and other budgeted items whose increases we cannot control. This will help us keep our annual assessments affordable for all.

As a reminder, SHLOA's web site, <u>www.shloa.com</u>, is up and running. On the SHLOA website you can access relevant information and upcoming events, SHLOA bylaws & covenants, archived newsletters, and more. Additionally, you can download and print information with just a click. Please visit the website and see how easy it is to access information about Sleepy Hollow on-line.

All newsletters are uploaded to www.shloa.com upon publication. However, please note that personal email addresses, phone numbers, and home addresses are "scrubbed" from posted newsletters and other on-line notices to protect the privacy of residents, lot owners, and members of the Sleepy Hollow Board. Emailed newsletters will not be similarly redacted.

Our 2nd and 4th Quarter newsletters will continue to be printed and mailed to each lot owner's address of record. The 1st and 3rd Quarter newsletters will only be published on-line at <u>www.shloa.com</u> as a cost saving measure. At its discretion, the Board will authorize the mailing of flyers to provide important information to all owners of record. Those flyers will also be posted on our website.

School Bus Stop Unsafe

Our bus stop is not safe! There is no place to park at the top of Mountain Lake Road and Audubon. There is no place for our children to get on or off of the school buses. The property owners on the corner of Mt. Lake Rd. and Audubon are within their rights to say "no" to parking on or plowing their property. That leaves nowhere to park but ON Audubon Road, blocking the entry/exit to Sleepy Hollow with our children literally "in the road." Our children deserve better than this and we all must come together to force a change, even if you do not have children getting on the bus. I'm sure at some time your way has been blocked by parents waiting to get children on or off the bus. And if both counties are waiting at the same time, it is a total block.
